Client/Organization or their owner(s), employee(s), or affiliate(s) (hereafter, "Customer") owes a deposit upon the date of execution of this agreement, or the

date noted in the Deposit Schedule above, whichever is sooner. Upon Waffle House's receipt of the Customer's deposit, Waffle House shall be responsible for providing the Food/Service items as described in this agreement. However, if Customer sends written notice to Waffle House, Inc. ("Waffle House") more than seven (7) days before the catering event, the deposit shall be refunded to Customer and the catering event shall be canceled.

If Customer requests any additional services or food items beyond what is specified in this agreement, all such services or menu items provided by Waffle House in response to Customer's request(s) shall be subject to additional terms and balance(s) owed by Customer to Waffle House. Statutory monthly interest at the rate of one and one-half percent (1.5%) per month shall be charged on any balance owed to Waffle House due more than thirty (30) days past the scheduled payment date. See O.C.G.A. § 7-4-16.

Waffle House and Customer are responsible for carrying their own permits and insurance coverage related to this agreement. Customer shall indemnify and hold harmless Waffle House from all personal injury and property damage claims asserted by non-Waffle House employees of, concerning, or related to the catering event. Customer shall pay reasonable attorney's fees and court costs, if any, that Waffle House accrues in collecting any balance related to this catering event. This agreement shall be governed and construed in accordance with the laws of the State of Georgia. Any and all legal disputes related to this agreement shall be submitted to the exclusive jurisdiction of the State Courts for Cobb County, Georgia.

This agreement may be withdrawn by Waffle House if its terms are not accepted, via signature below, within thirty (30) days of presentment to Customer.
